COMMISSION DECISION

of 9 June 2006

on instructing the Central Administrator of the Community Independent Transaction Log to enter Luxembourg's National Allocation Plan table into the Community Independent Transaction Log

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 2216/2004 of 21 December for a standardised and secured system of registries pursuant to Directive 2003/87/EC of the European Parliament and of the Council and Decision No 280/2004/EC of the European Parliament and of the Council¹, and in particular Article 38 (1) thereof,

Whereas Luxembourg notified its national allocation plan table to the Commission by letter registered on 12 April 2006, the Commission finds that the notified national allocation plan table corresponds to Luxembourg's decision taken under Article 11 of Directive 2003/87/EC and is based upon the national allocation plan notified by Luxembourg, to which the Commission did not raise any objections in its decision of 20 October 2004 under Article 9(3) of Directive 2003/87/EC,

HAS DECIDED AS FOLLOWS:

Article 1

The Commission instructs the Central Administrator of the Community Independent Transaction Log to enter Luxembourg's National Allocation Plan table into the Community Independent Transaction Log in accordance with the initialisation procedures set out in Annex XIV of Commission Regulation No 2216/2004.

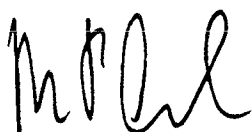
